



**Minutes of the 68th ANNUAL GENERAL MEETING of  
THE ALUMNI ASSOCIATION  
June 16, 2017, 12 p.m. – 12:30 p.m.  
Western University Campus, New FIMS/Nursing Building**

**1. CALL THE MEETING TO ORDER**

Alumni Association President, David Simmonds, called the meeting to order at 12 p.m. and welcomed everyone to The Alumni Association's Annual Meeting, noting that the meeting is an opportunity to formally record and celebrate the achievements of the past year and to thank Alumni Association volunteers.

Mr. Simmonds announced that notice of the meeting was published 45 days prior to the meeting date and that a quorum was present allowing business to be undertaken. Donna Swanson, Administrative Assistant in Alumni Relations, was asked to serve as Secretary of the meeting.

Mr. Simmonds informed the attendees, that following the business portion of the meeting, guests were invited to have lunch and participate in tours of the building. Mr. Simmonds acknowledged the past Presidents who were present in the room.

**2. MINUTES OF THE LAST ANNUAL GENERAL MEETING**

Members received the minutes of the last Annual Meeting of members, dated June 16, 2016. As there were no amendments or changes to the minutes, the President asked for a motion for approval of the minutes.

**3. APPROVAL OF THE ACTS OF THE DIRECTORS**

Mr. Simmonds advised the members that approval of all the decisions made and actions taken by the Board of Directors and Officers of the Association since the last Annual Meeting is sought and that a list of these motions were circulated at the meeting. The President asked for a motion to approve the Acts of the Directors.

**4. PRESIDENT'S REPORT**

Mr. Simmonds presented the Alumni Association's Strategic Plan. David noted the plan was created over 18 months which involved a great deal of listening and prioritizing. David reported that five pillars were carefully crafted to give us a clear line of sight to the core priorities that will see us leading and advancing for several years to come and are aligned with our structure as a board. David noted key messages from alumni that helped to shape the Plan:

- Alumni told us that they wanted to support the Association and they are willing ambassadors of this institution;
- Alumni advised they needed a clear signal from us as to how they can lend a hand; and
- Alumni let us know that we needed clarity in our messages and direct calls to action.

David reviewed the five pillars: Extraordinary Stories. Extraordinary Benefits. Extraordinary Leadership. Extraordinary Experiences and Extraordinary Network.

David advised that the Board of Directors and staff team are well positioned to execute each tactic and are excited to begin the next phase of alumni engagement and welcomed any feedback.

Mr. Simmonds directed members to review the 2017 Western Alumni Progress Report that was circulated at the meeting. Notable accomplishments from this year:

- Metrics from our successful ‘doubling alumni engagement campaign’ where we have surpassed our goal of engaging 100,000 alumni;
- Results of our nation-leading programs: Discover the World Travel, Senior Alumni Program, the Career Management Portfolio;
- Showcase of our new digital engagement campaigns – namely our ‘Kind Mail’ and ‘It’s on Me’ initiatives that assisted students during stressful exam periods and gave alumni the opportunity to reach out and give back;
- Through our Legacy Committee we allocated \$566,000 dollars back to some of Western’s highest priority needs. We supported the faculties of Music, Education and Arts & Humanities with capital projects and we contributed to ground-breaking concussion research;
- Goal to meet gender parity on the Alumni Association’s Board of Directors for 2017 – 2018 was met and exceeded: 11 female and 7 male directors; and
- Western Alumni hosted its first LGBT reception on June 14 in Toronto.

## **5. REPORT OF THE NOMINATING COMMITTEE**

Mr. Simmonds reported that the Nominating Committee met several times over the course of the last year to discuss candidates for The Alumni Association Board of Directors, which includes Alumni Association representatives on the Board of Governors and appointments to other University bodies, including the University Senate and its Honorary Degrees Committee.

Mr. Simmonds announced that a Past President's Award Fund, previously held by Foundation Western to honor the dedication and service of its Presidents, is now doing the same for outgoing Presidents of the Alumni Association. David reported that the second Western Alumni Past President's Award will be established and named in recognition of John Eberhard and his contributions to the Alumni Association as President from 2014-2016. The awards are valued at \$1,500 each and will be given to deserving Western students for a ten-year period. David noted that John directed the funds to the Faculty of Law where they will be added to an existing bursary in honour of one of his mentors, the Late Bill Poole.

**7. OTHER BUSINESS**

Jim Etherington requested that the establishment of an Alumni Association at Western be recorded as 1906 not 1949.
